




TRUST DEED

. NAME

The name of the Trust shall be M.R.FOUNDATION.



- 3.24 To invest the money of the trust, not immediately required in such securities or in such manner as may, from time to time, determined by the wound of Board of Trustees.

7.5 The Board of Trustees shall be competent to function notwithstanding any vacancy therein and notwithstanding any defect in its constitution and no act or proceeding of the Board of Trustees shall be invalid by any reason of the existence of any vacancy amongst its members or any defect in their appointment of any trustee.

- 7.9 The Managing Trustee may, of his own accord, and shall if required to do so by requisition in writing signed by not less than half of the total member of the Board of Trustees call after the notice of at least 21 days, a Special Meeting of the Board of Trustees.
- 7.10 The President or in his absence one of the Vice-President shall preside at the meeting of the Board of Trustees.
- 7.11 Every question shall be decide by the Board of Trustees by majority of those present. Every member of the Board of Trustees shall have one vote and in case of qualify of votes the President of the meeting shall have a second or casting vote.

The Accounts of the Trust shall be audited by the Auditors of the Trust appointed by the (KERM) Managing Trustee, who will hold office till the conclusion of the next annual general meeting wanter and shall be eligible for re-appointment.

7.13 The rules of the Trust except Rule 7.2(a),(b),
(c) and (e) may be altered by a resolution

passed by a two-third majority of members of the
Board of Trustees present and voting in a

meeting convened for this purpose.

- 7.14 The appointments in any establishment constituted under the Trust shall be made by the Board of Trustee. The head of the institute so appointed shall have all powers to perform all such outles as are given to him by these rules or may be delegated to him by the Board of Trustees. If any trustee is appointed to hold the office of any such establishment he will be elegible to draw remuneration as approved by the Board of Trustees.

- 7.16 The bank accounts of the trust shall be kept in one or more scheduled bank and it shall be maintained and operated by the Managing Trustee or a person(s) nominated by the Managing Trustee.
- 7.17 The Trust hereby shall be irrevocable.
- 7.18 All the provisions of the Indian Trust Act, 1882 unless otherwise specified in this Trust Deed, shall be applicable for this Trust.
